## Chandra Asri Petrochemical Supports The Implementation of Plastic Road in Cilegon

**Jakarta, 14 February 2019** – PT Chandra Asri Petrochemical Tbk (CAP), the largest integrated petrochemical company in Indonesia and City Government of Cilegon signed Memorandum of Understanding (MoU) for the construction of asphalt road with mixture of plastic bag waste for 10 kilometers long in Cilegon.

The MoU is signed by CAP President Director, Erwin Ciputra and Acting Mayor of Cilegon, Edi Ariadi. These collaboration is part of CAP's support for Indonesian Government in plastic waste management. According to research conducted by Indonesian Ministry of Public Work and Public Housing (PUPR), the stability of asphalt road with mixture of plastic bag waste, type High Density Polyethylene (HDPE), increase to 40 per cent.

“Our support will take form of provision of approximately 30 tonnes shredded used plastic bag, for the asphalt road mixture constructed by City Government of Cilegon,” said Suhat Miyarso, Vice President Corporate Affairs CAP who was also present in the occasion. “We hope the utilization of used plastic bag in the asphalt mixture would change public perception in seeing used plastic bag, from not valuable to very useful product,” he added.

CAP will provide shredded plastic bag to City Government of Cilegon, for mixture in asphalt materials. These program is planned to be implemented in 2019.
